New Delhi, the 16th October, 2018

S.O. 5323(E).—In exercise of powers conferred by sub-section (1) of section 50 of the Prohibition of Benami Property Transactions Act, 1988 (45 of 1988) and in consultation with the Chief Justices of the respective High Courts, the Central Government hereby designates the court(s) of Session, as mentioned in Table below, as Special Court(s) for the area(s) specified in the said Table against the said courts, for the trial of offences punishable under the provisions of the said Act.
